


CCNA's strength lies in the collective wisdom and collaboration of its members

CCNA support

- Through monthly meetings and shared initiatives, CCNA:
 - Encourages networking and knowledge exchange among neighborhood leaders
 - Unifies concerns across multiple neighborhoods for greater impact
 - Launches initiatives based on member input and Board capacity
 - Maintains regular communication with city commissioners
 - Assists with navigating city/county processes and identifying relevant staff contacts

Elevating issues

- Any member of a Neighborhood Association, resident, or business owner
- General process
 - The NA President/Delegate identify a need & prepare a request.
 - Area Directors—first point of contact
 - Directors may escalate issues
 - Neighborhood Reports segment of CCNA


