**1. Meeting Call to order at 9:00 AM.**

**4. Acknowledgment of Guests** – Norm Dumaine

**5. Police Report – Officer Danny Robbins.** Thank you to City Manager Marlon Brown and Deputy City Manager Pat Robinson for promoting Rex Troche to Chief of Police. Thank you for your leadership. City-wide monthly crime stats are posted on the CCNA website. Crime stats are also mapped by neighborhood on our website. A reminder to please lock up your cars and lock your houses. Help us out. **6. Guest Speakers**

A. County Administrator Jonathan Lewis and City Manager Marlon Brown presented on the Sarasota One Cent Sales Surtax renewal. Both presenters participated in a question and answer session.

1. County Administrator Jonathan Lewis provided a power point presentation on the one cent sales surtax renewal plan, up for county wide vote. Details on the one cent surtax may be accessed at the [SarasotaCountySurtax.net](http://SarasotaCountySurtax.net) website.

2. City Manager Marlon Brown presented details on the City of Sarasota's utilization of one cent surtax revenues. The purpose of the one cent surcharge revenue is for capital improvements only. This is the fourth extension of the surcharge and is for a period of 15 years.

B. City of Sarasota Planning Director Steve Cover presented on proposed changes to the City's Comprehensive Plan. The changes will be presented to the City Commission for vote on May 16. Proposing changes to two chapters of our Comprehensive Plan. The first is housing and the second is future land use. The three impacted areas are: 1. Commercial Centers. 2. Commercial Corridors. 3. Downtown Sarasota. What we are facing in the city – particularly as it relates to affordable housing - is a rapid escalation in housing cost. Rents in the last year are up 44%. A lot of the focus on what we are doing is along the Corridors, the Commercial Centers and Downtown. Steve Cover's presentation detailed some of the zoning text amendments that will be the result of the comp plan changes. His presentation concluded with an extended question and answer session. Q&A major issues centered on three issues: 1). Building height changes; whether in the future, they will be subject to an individual zoning text amendment 3/2 vote, versus the present comprehensive plan change, super majority 4/1 vote. 2). expansion of Administrative Approval outside the downtown zone. 3). Feasibility of incentivizing construction of affordable housing.
